SPACE FLIGHT MEMORIAL FOUNDATION

Space Center Rotary Club, as community leaders of the Clear Lake Area, has undertaken the leadership role in the task of building a Space Flight Memorial on or near the Johnson Space Center. This endeavor is intended as a lesting memorial to all Americans who have lost their lives while engaged in the exploration of space. The interfaith memorial will be open to the public for spiritual meditation and to the astronauts themselves for spiritual ceremonies. The memorial will consist of a primary structure and memorial gardens with accommodations for visitors. The primary structure will contain a meditation area and a display area/museum. Planning for the memorial is being integrated into an overall plan to develop a new visitor's center at Johnson Space Center. The memorial will include a tribute to every astronaut involved in the United States space program whose dedication and bravery are opening the frontier of space for the benefit of mankind.

Funding for the memorial is being raised through private individual, institutional, and corporate donations. The board of Space Center Rotary has voted to advance \$10,000 in seed money for this project. It is hoped that construction for the memorial can begin within a year.



You can be a better individual as well as a better Rotarian if you:


