

The cost of the service is paid by the creditors, who end up realizing a larger recovery than by other methods. Dave King asked a cogent question of the speaker: "With the thought that an ounce of prevention is worth some larger amount of cure, is there an education program for young people in high school to learn the lesson of overuse of credit?" 




