PROGRAM NOTES

MEETING OF JULY 13: Our affable Jim Wyatt introduced fellow HL&P-er Glenn Baird, who brought us information on the South Texas Nuclear Project. By coincidence (or otherwise?) the loading of nuclear fuel pellets was beginning that week. Baird brought schematic drawings to show the vast difference between this US plant and the Russian Chernobyl plant. The Chernobyl plant did not have a radiation containment structure and used carbon for the cooling medium, whereas the STNP has a containment structure (the familiar dome) and uses water for its cooling medium. At Chernobyl, when the plant operators attempted to load fuel while still operating the plant (which is not done in US plants), the heat generated ignited the carbon which further increased the heat and led to a melt down. There is also a great difference in the training programs for plant operators. The Russians are now incorporating the more rigorous system used in the US into their training. (Cont'd p.2)


MEMBER PROFILES
