





MEETING OF MAR 21: Rev. B. J. Cannon introduced District 338 Court Judge Mary Bakin and Jean Genderson, Executive of the Community Service Option Program, a private non-profit organization that serves as Harris County's clearinghouse for the placement of court-ordered volunteers with non-profit organizations. This allows offenders to make restitution to the community, thus paying back their debt in a positive way. This tradition comes from England and has provided Houston area non-profits with \$2 million in free services over the past year. Of 9000 that have come through the program, only 5 have been repeaters.

MEETING OF MAR. 28: Jerry Jones introduced Ralph McPheters, who shared slides and exciting plans with us about the \$118 million development project to create a world class garden tourist attraction on Galveston Island. This should be a boon to tourism both for Clear Lake and Galveston. On the same site there will be a program for brain-damaged children and adults which uses horses and other animals in a creative and effective therapy program.

(Continued from page 1) So what can cause us to lose this privilege?

Other than nonpayment of dues, any member absent from four consecutive regular weekly meetings, unless his/her absence is made up, or he/she is excused by the Board for a good and sufficient reason, will have his/her membership automatically terminate.

You may make up an absence from our meeting by attending a regular meeting of any other Rotary Club between "the usual time of the regular meeting of this club immediately preceding the day of absence and usual time of the regular meeting of this club immediately following the day of absence."

HUH? In non-legalese this essentially means from Tuesday of the week before you miss a meeting through Sunday following the meeting you miss. That's roughly a two week span. If you wanted to be picky, I suppose you could attend a morning meeting on the Monday


There is also a requirement of attendance of at least thirty percent of your home club meetings during each six month reporting period (no matter how much you make up) unless excused for good reason by the Board.

Various other provisions in our constitution allow credit for attendance at other Rotary functions (such as the upcoming District Conference in Acapulco), but the minimum criterion for attendance is sixty percent of the regular meetings unless excused for good cause by the Board.

Remember, membership and attendance are both privileges and somewhat akin the tax deductions. Yes sir. according to Dave King, "use it or lose it!"
