


Rotary Club of Houston makes Baker Tribute a Record Success

More than 800 people filled the Imperial Ballroom at the Hyatt Regency Downtown Houston on November 20th to witness Secretary James A. Baker, III receiving the Rotary Club of Houston's 45th Distinguished Citizen Award (DCA). It was the most successful DCA event in the club's history, with more than \$500,000 being raised for the Rotary Club of Houston Foundation.

Honorary Co-Chairs were President and Mrs. George H.W. Bush and Secretary and Mrs. Robert Mosbacher, Sr. Rotary Co-Chairs were Meredith Iler and Michael Barnes.

With South Dakota Senator John Thune serving as a very efficient Master of Ceremonies, the first speakers were Secretary Baker's sons, Doug and John, who praised their dad for his integrity and patience, and told of his five P's: Prior Preparation Prevents Poor Performance. Next speaker, former Secretary of Commerce Bob Mosbacher, named Baker one of the greatest public servants of our time. Bill Barnett, chairman of the Baker Institute at Rice University told how Baker

once said that his value after such high Washington positions would only last 2 or 3 years. Since that was spoken in 1993, Barnett concluded that Baker was not good at prophecy. Finally, His Royal Highness Prince Turki of Saudi Arabia praised Baker for his leadership on the world stage and his pivotal role in co-chairing the Iraq Study Group.

Baker said that after spending the first half of his life on the sidelines, he suggested that life is more meaningful and satisfying if one gets in the parade. Mr. Baker's memoir: Work Hard, Study... and Keep Out of Politics! Adventures and Lessons from an Unexpected Public Life—was published in October 2006.



The evening concluded with a surprise presentation of a new home to Corporal Paul

Gardner, USMC, in honor of Secretary Baker's service in the Marines. Joining Mayor Bill White and Mayor Dave Wallace in the presentation were Congressional members Sheila Jackson Lee, Kevin Brady, Michael McCaul and Shelly Sekula-Gibbs; war hero, Captain Scott O'Grady; Judge Robert Eckels; Secretary of State Roger Williams; and business leader Meredith Cullen.

Reflecting on the evening, President Vicki Brentin said; "Secretary Baker truly lives our motto of "Service Above Self". What a deserving recipient of our Rotary Distinguished Citizen Award."

Projects Are Available

Governor Suzi Howe reports that her office has received several proposed projects from Rotary clubs is Mexico in District 4150. Some are from the Club Puerto Vallarta Pitillal. They are:

- I) To provide 15 custom made prosthesis for people, with little or no income, at a total cost of US\$12,000, The projected funding includes US\$3,000 from a sponsoring District 5890 club; US\$1,000 from the Pto. Vta. Pitillal club; US\$2,000 from 5890 DDF; US\$1,000 from the District 4150 DDF and US\$5,000 from TRF.
- 2) To provide manual hospital beds, bed wear and linen for senior citizens in a Shelter Center, at a total cost of US\$12,000, The projected funding includes US\$3,000 from a sponsoring District 5890 club; US\$1,000 from the Pto. Vta. Pitillal club; US\$2,000 from 5890 DDF; US\$1,000 from the District 4150 DDF and US\$5,000 from TRF.

Club Rotario Bahia de Banderas has proposed several also. Two of them are:

- I) Casa Comunidad is a non-profit organization dedicated to helping children and adults develop the necessary skills to be successful, positive contributors to their multi-national, bilingual community. Their need is for funds to support and enrich their current programs. Funds will be used to purchase needed furniture, computers, and materials for English, Art and computer classes. The budget is \$25,000 USD. Their club will provide \$6,250 USD and 5890's sponsoring club a like amount. These two sums are assumed to include DDFs. TRF will be asked for \$12,500 USD.
- 2) The club has as it goal to provide uniforms, school supplies to 150 middle school students. Without this support, these students from lower income families can not continue to attend school. In addition to their uniforms and supplies, the students will receive economic support for tuition and transportation from the Becas Vallarta A. C. The total need is \$24,000 USD. Their club will provide \$6,000 USD to be matched with a like amount from a 5890 sponsor club. \$12,000 USD will be requested from TRF.

The sponsoring club from 5890 will have the opportunity to visit with project leader during the District Conference this spring.

Council on Legislation Update

In 2007 the Council on Legislation will meet from April 22-27 in Chicago. This body is the legislature for Rotary International. It repeals, amends and creates the laws governing Rotary International, the Districts and the Clubs and only meets once every three years.

The time to make proposals ended June 30, 2006 and we are now studying the proposals and preparing to discuss, debate and vote. I recently received two volumes of proposed legislation to the Council made by the clubs, districts the RI Board, and the General Council of RIBI.

In addition to the proposal, each had to also have a financial impact statement. In total, there are 520 pieces of proposed legislation. The clubs of District 5890 made two proposals: district finances and membership.

The financial proposal is to allow the district to appoint an independent audit committee to audit the books of the district. The current rules allow for only an outside accountant to do a review engagement. A review is not an audit. The committee approach will allow for a more in-depth inspection of the books as for example: to compare financial activity to authorized expenditures by comparison to the approved budget or approval of the finance committee; and, a more detailed review of support documentation.

The membership proposal by District 5890 would allow Foundation alumni to join a club even if the classification for the proposed alumni is filled. This exception to the classification limit is already permitted for transferring or former members of a club.

District 5890 2006-07 Multi-Club Project

The Rotary East End Initiative has been successful in establishing several public health projects including Back –to-School Immunization Events, the Espiritu de Salud/Spirit of Health Mobile Health Unit, the El Centro de Corazon Pediatric Room and most recently the El Centro After Hours Urgent Care program. The Initiative is now broadening its reach to include education activities.

Please join District Governor Suzi Howe in her vision to support a Montessori program in the Casa de los Ninos Barbara Bush — a state of the art literacy center that will be part of a major expansion for the Community Family Center and make a huge difference for East End families. This multi-club project will equip a Montessori classroom and also establish a ROTARY PARK in the St. Luke's playground that adjoins the Casa de los Ninos Barbara Bush and the John D. McGovern Gymnasium.

DG Suzi has already pledged \$25,000 from District funds and is asking interested Rotary clubs and individual Rotarians to also contribute funds. 
