Leadership development fuses personal growth, Rotary ethics

To foster the development of leadership skills and increase awareness about Rotary at the club level, the RI Board recently created the optional <u>club-level trainer position</u>. RI provides basic guidelines, but how clubs and districts implement the program is limited only by their own creativity.

During the past two years, members of two Rotary clubs in El Paso, Texas, USA, have developed a unique training program called the Institute for Leadership, which focuses on cultivating individuals as leaders and fusing Rotary values with personal growth concepts. The two-day leadership development seminar was developed by a Rotarian team that includes Past RI Vice President Irving J. "Sonny" Brown and three professional leadership trainers (all past club presidents and a governor-elect). Though initially planned for Rotarians alone, the training program is now offered as a community service to other organizations or individuals. The institute can help serve the community and attract prospective members to join a Rotary club.

How does it all work? We sat down with Brown to find out.

Q: Why did you create the Institute for Leadership training program?

A: We wanted to provide Rotarians with a personal growth experience that would serve them not only in Rotary but also in their family, business, and community — without great expense and time.

Q: Who participates?

A: The program is uniquely Rotarian, but not only for Rotarians. We want to promote Rotary as an avenue for personal growth to all (Continued on page 6)

South Africa is wonderful. Durban has beautiful rolling hills, and the people are extremely nice. I was greeted by 10 members of the Rotary Club Berea when I arrived. Everyone has been very hospitable and generous. They are an interesting and kind group of people. The club is currently working on a project at a school in Madikane. I am going to get involved. The school does not have basic necessities such as shelves or working toilets.

A few months ago, the principal received filing cabinets. I am going to make a brochure with pictures and statements from the principal and students, and I will send it.

I have finally gotten settled in Durban and

moved into a house two days ago. It is great because I have much better Internet connection now. I live about 10 minutes away

from the university where I am starting research on HIV/AIDS and youth.

In South Africa, KwaZulu-Natal has the highest number of HIV infections as well as a climbing number of orphans. I am looking forward to getting involved with a

program called Children First, which is a children advocacy group. They do community projects and work to build self-esteem and empowerment in children affected by HIV/AIDS, poverty, etc.

The other day I participated in a project called Feedback. The project takes place across South Africa. Businesses and grocery stores donate extra food. The food is then delivered all over Durban and the surrounding areas to needy groups that are working to help their own communities.

I traveled through townships, the inner city, and the rural areas. It was wonderful and amazing because the people you are bringing food to are so generous.

I am also attempting to learn Zulu. It will take awhile to master the three clicks that are a part of the language. I am unable to download pictures right now, because I am missing a cord. As soon as I can I will be setting up a web site and will send pictures of the area, people, and projects.

I feel blessed with the opportunity Rotary has given me. I will do my best to be an ambassador of goodwill. I know I will say it many times in the future as well, but thank you from the bottom of my heart for this opportunity.

Humble and Highlands Clubs Partner for San Salvador Project

The Rotary Club of Humble Intercontinental recently partnered with the Rotary Club of the Highlands, a small Rotary Club in San Salvador, the Rotary Foundation and Engineers Without Borders to fund and drill a water well in a small community in San Salvador.

This community, located on the outskirts of San Salvador, consists primarily of people who fled the countryside during the civil war from 1979 to 1992. Because of the forced nature of their relocation, the community's infrastructure was never properly developed, including their water source. Since they could not afford a drilled well, they hand-dug one well for 70 families.



The project was born when Humble Rotary Club president Bill Davis met a representative from Engineers Without Borders last year. The partnership moved forward with the water project in Colonia Esmeralda in San Salvador, said Davis. "The two-part project will serve about 500 people residing in 88 dwellings in the community", Davis said. The first phase of the project was a deeper water well that would supply clean water to the community. The second phase is the construction of a retaining wall to protect the community from washing away during the rainy season.

Davis recently traveled to San Salvador to view the progress of the water well and the retaining wall.

Briefing his fellow Rotarians on the project at a recent luncheon, he reported "many communities in the world lack access to clean water. This causes illness and death in these communities, especially among children. The existing well is shallow and eventually became contaminated. It can only be used for washing clothes."

Other communities without a reliable source of clean water often depend upon seasonal water sources such as streams, creeks, rivers or lakes, many of which are easily contaminated by animal or human waste.

A community member has been hired to maintain the new well and turn the pump on to the three distribution points in the community. While Rotarians supplied the funding for the project, the members of the community are required to contribute their labor to the program, he said. Every male member of the community is required to donate 56 hours of time to build the retaining wall. Women without an adult male family member are expected to help provide food for the workers.

"The remnants of El Salvador's civil war and unrest are still visible on the buildings and on the mentality of the people", said Davis. "Bullet holes in buildings are easily seen and armed guards are everywhere. The civil war was just terrible for them and the big problem now is gangs."

During his trip he was warned of people being kidnapped for ransom. Homeowners are security conscious with gated and guarded homes with high concrete walls often topped with razor wire. In spite of those concerns, the welcome he received from the people of Colonia Esmeralda was warm and gratifying. The people were friendly and turned out in their best finery for a community gathering to celebrate the completion of the well.

The retaining wall is expected to be completed within the next week or two. Although the San Salvador project is complete, The Rotary Club of Humble Intercontinental's leadership voted to continue its clean water efforts. It is partnering on two more water well projects, in Bolivia and Kenya.

Yeiter Reports on New Tax Break

In 2006 and 2007 only, donors age 70 $\frac{1}{2}$ or older may annually transfer up to \$100,000 from their Individual Retirement Account (IRA) to The Rotary Foundation without increasing federal gross income.

This is great news for supporters of the Foundation who wish to turn retirement assets into charitable gifts during their lifetimes, but have been discouraged from doing so due to increased income taxation. Immediate action is required to take full advantage of this provision. Without the tireless efforts by dedicated Rotarians like John Taylor, Rhonda and Eric Kennedy, the Economic Development Committee, Regina Slayton with Chevron Phillips, and all of the other fine Sweeny Rotarians who sold Harley Raffle tickets, this building for the Community could not be built.

members and prospective members. For Rotarians, we try to inspire and awaken greater passion for leading and serving through Rotary. We want Service Above Self to come alive in every Rotarian.

Q: What's on the agenda?

A: We don't deal with Rotary club management or Rotary information, but rather focus on Rotary values such as ethics and leadership. Our interactive exercises cover subjects such as collective potential, building rapport and teamwork, leadership styles, coaching and development, leadership commitment, the art of listening, and leading by example. We also incorporate essential Rotary values, such as The Four-Way Test, the Object of Rotary, and the Declaration of Rotarians in Businesses and Professions.

Q: What inspired you and your colleagues to develop this program?

A: Most of the organizers have been involved in RYLA for years. Of course, RYLA focuses on fostering youth leadership, but all Rotarians who are personally involved in RYLA find their own leadership skills become greatly enhanced at the same time. So we thought to ourselves, "Why not offer a 'RYLA for Rotarians'?" It was an exciting prospect! Since we began planning in November 2001, over 200 participants have graduated, and more than 30 have become Rotary club presidents. Other participants have become officers or board members of their clubs. We have been actively promoting the program in neighboring districts, and currently five districts have started their own program. Attending the most recent event [16-17 March] were representatives of three Rotary districts from Oklahoma, Arizona, and another Texas district. Incoming Director Phil Silvers joined this latest group as a participant.

Q: How does the program help Rotary?

A: As individual Rotarians develop their leadership skills and enhance their personal growth, they gain a deeper understanding of Rotary values. All of that serves to build Rotary's future. Rotarians who invest two days in our program gain a lifetime understanding of who they are as leaders. We help them identify skills that will enable them to perform as leaders at the highest possible level. Most importantly, the meeting helps participants discover themselves and brings out the great potential that is within each Rotarian.

Q: How can others get involved?

A: Just contact me via an e-mail. We have an open invitation to any district to send representatives to

our seminars, so that they gain a personal understanding of the benefit and the challenge of starting such a program. The program has been so successful in its designed format that we are excited to share it with districts that wish to start their own event. It all starts with training facilitators who have participated in one of our seminars. To assist other districts in starting the program, we are very willing to send members of our team to assure that the training of their trainers is complete. Follow-up support is always available, as may be requested.
