

In numbers 3 through 6, indicate the class of permit or license required and complete the appropriate section. All questions regarding the particular temporary license you are applying for must be answered. Your receipt is your license. Post it in plain view at the location stated in number 9.

INSTRUCTIONS FOR ACCOUNTING AND REPORTING OF MIXED BEVERAGE TAXES (FOR A DAILY TEMPORARY PERMIT ISSUED TO A PRIMARY MIXED BEVERAGE OR PRIVATE CLUB PERMIT)

- 1. Alcoholic beverages sold or served must be purchased separately from those sold or served under the primary Mixed Beverage Permit or Private Club Registration Permit.
- After the Daily Temporary Mixed Beverage Permit or Daily Temporary Private Club Permit expires, an inventory of the remaining alcohol must be prepared. A copy of this inventory shall be retained by the mixed beverage or private club permit holders and a copy shall be forwarded to the local office of the Comptroller of Public Accounts. After this inventory is completed, the unused alcoholic beverages must be transferred to and used by the primary mixed beverage or private club permittee.
- For information on reporting the mixed beverage taxes generated under the Daily Temporary Mixed Beverage Permit or Daily Temporary Private Club Permit and inventory of remaining alcoholic beverages, please contact the local office of the Comptroller of





ARTICLES OF INCORPORATION

Corporations Section THE ROTARY CLUB OF SPACE CENTER, HOUSTON, TEXAS

I, the undersigned natural person, who is of the age of eighteen (18) years or more, acting as incorporator of a corporation under the Texas Non-Profit Corporation Act, do hereby adopt the following Articles of Incorporation for such corporation:

ARTICLE I

Name

The name of the corporation shall be THE ROTARY CLUB OF SPACE CENTER, HOUSTON, TEXAS.

ARTICLE II

Non-Profit Corporation

This corporation is a non-profit corporation.

ARTICLE III

Duration :

The period of its duration is perpetual.

ARTICLE IV

Purposes

The purposes for which the corporation is organized are to function as a service club or organization as defined in Section SUI(c)(4) of the Internal Revenue Code of 1954 or corners federal fax code, or experiending acotton of any future federal tax code. Notwithstanding any other provision of these Articles, the corporation shall not carry on any other activities not

permitted to be carried on by a non-profit corporation under the law and statutes of the State of Texas.

ARTICLE V

Members

The corporation shall have members in accordance with its constitution and bylaws.

ARTICLE VI

Initial Registered Office and Agent

The street address of the initial registered office of the corporation is 1300 Hercules, Houston Texas 77058, and the name of its initial registered agent at such address is Billy R. Smith.

ARTICLE VII

Board of Directors

The affairs of the corporation shall be managed by a Board of Directors.
